Dear Member,

In the March Newsletter there was discussion about the devastating bush fires in south eastern Australia. We were able to fit in a Friends meeting on the 3rd March and then within a week the COVID-19 virus saw the closure of international flights, schools, playgrounds, a shutdown of businesses and most sports, and shortly after a lock-down of state borders and a restriction in community movement.

We were all asked to stay at home in isolation and to work from home, if you could. The speed with which COVID-19 has forced us to adapt and change has been extraordinary. The virus has led to the postponement of the Volunteer program that was due to recommence in April. This recent outbreak in parts of Melbourne is an indication of how contagious this virus is.

During the period of isolation one of the permitted reasons for leaving your home was for health and fitness. Council quickly placed signage in the Gardens to advise visitors of the need to keep 1.5m apart and Lumley Playground was closed. Being a regular visitor to the Gardens, I have never seen them so popular. It was during this period that the Royal Botanic Gardens, National Trust gardens and some other gardens in our area were closed.





Lumley Playground Upgrade:



The playground construction works are proposed to commence at the end of June/early July 2020. Council previously contacted local residents and park users in October 2019 to seek feedback on the draft concept plan. Following a review of the feedback received, Council has developed a final concept plan for the playground upgrade.

Updates to the previously issued draft concept include:

- Inclusion of an additional piece of fixed play equipment (climbing posts and bars)
- Revised north-east entrance arrangement with arbour to provide a buffer and control path of travel between the entrance and the swings.
- Allowance for gated access to the toilet block direct from the playground.
- Exchange of the shelter structure for new shade trees to distribute shading across a wider playground area and to allow for natural light in winter.
- A meandering pathway with a central donutshaped timber seat and central tree.
- Addition of a new recycling bin and updated seating locations.
- Formalised area of bound gravel in the northwest corner to serve as pram parking, maintenance access or kindergarten assembly point, as required.
